A voluntary conservation initiative that provides financial and technical assistance to agricultural producers to treat identified soil, water and related natural resources concerns on eligible land with financial and technical assistance.

 An NRCS planner will meet with you & help determine your objectives, collect information and discuss applicable conservation practices.

### Submit your application, along with any required documents.

 NRCS ranks all applications using an "environmental ranking matrix".

### Applications that rank the highest are funded first, until all funds have been expended.

# If approved for funding, you sign a contract.

Then:

 Once funded (money set aside for your project) you can begin construction, during which time you will work closely with your planner to make sure practice requirements are met.

### Once practices have been installed, contact NRCS for a field inspection.

### Once practices have been inspected and certified, you will be reimbursed based on the payment rate in your contract!

### **VERY IMPORTANT:**

**VERY IMPORTANT:**  Do NOT purchase parts or begin installation before officially funded!
